BOOKING CONTRACT

It is mutually agreed that the following terms of the agreement form an integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by The Photographer in writing.

BOOKING FEE A booking fee of £250 is charged when the Client signs this contract. This fee is deducted (in full) from the total price on completion of the contract.

PAYMENTS The balance of coverage fees due are to be paid upon collection of image previews. A deposit of 50% is requested at the time of placing a reprint order. Print prices are guaranteed for 3 months from the date of the wedding.

DISPLAY I hereby allow the Photographer to display any photograph included in this contract in his Studio or Portfolio. No use of the photographs will be by the Photographer for other commercial reasons except with the permission of the customer in writing.

PHOTOGRAPHS All photograph sizes are nominal. The Photographer will provide a pleasing colour balance but cannot guarantee exact colours. Owing to anomalous reflectance caused by a combination of certain dyes and materials, especially man made fibres, it is sometimes impossible to photograph the exact colour of materials as seen by the human eye.

RETOUCHING Retouching and digital manipulation is available as an optional extra.

COPYRIGHT The 1988 Copy Act assigns copyright the The Photographer it is contrary to the Act to copy or allow to be copied photographically/electronically or by any means an image created as part of this contract without the permission of The Photographer in writing.

LICENCE The Photographer shall be granted artistic licence in relation to the poses photographed and the locations used. The Photographer's judgement regarding locations/poses and the number of photographs taken shall be deemed correct. Due to the vagaries of the weather and the willingness of subjects it may not be possible to capture all the photographs requested.

FORCE MAJEURE OR ACT OF GOD The due performance of this contract is subject to alteration or cancellation by The Photographer owing to any cause beyond their control in the unlikely event of a total photographic failure or cancellation of this contract by The Photographers liability shall be limited to a full refund of all monies paid.

CANCELLATION The Client may cancel this contract at any time by giving written notice to The Photographer and shall forfeit any monies paid. Should cancellation be received by The Photographer less than eight weeks prior to the date of the ceremony The Photographer reserves the right to request an additional fee of £250 in compensation for loss of income for the day booked.

IMAGES Image files remain the property of The Photographer and shall be permanently filed.

PRICES All services and/goods are supplied at the prices ruling at the time of supply and are subject to the then current rate of V.A.T.

COMPLAINTS Any complaints should first be raised by the Client with the Photographer in writing within 21 days from the date of the Pre views being collected. In the unlikely event of an unresolved complaint the Client may request the Master Photographers Association to concilliate whose decision shall be final and binding upon both parties.
